TERMS AND CONDITIONS

4. Where the annual or upfront payment option is selected, and payment is made by debit / credit card, additional payment processing fees of between 3% and 4.5% will apply. The fee varies depending on the type of card used. Where the monthly payment option is selected, the monthly instalment amount is inclusive of card fees.
5. The applicant acknowledges that the application will not bind the applicant and the Wellington Regional Stadium Trust (“the Trust”) until it is accepted in writing by the Trust.
